Terms and Conditions:

- 1.Lots of Love Pet Care with Wendy agrees to provide pet sitting, dog walking and other applicable pet care services in a reliable, caring and trustworthy manner. In consideration of the services and as an express condition thereof, the client expressly waives and releases Lots of Love Pet Care with Wendy from any and all claims against the company, its owners, employees and representatives, except those arising from negligence or willful misconduct on the part of Lots of Love Pet Care with Wendy.
- 2. Client agrees to notify Lots of Love Pet Care with Wendy of any concerns within 24 hours of completion of services.
- 3. Client agrees to pay all charges accrued for services rendered. Client understands that payment is due at or prior to the time of the commencement of services unless explicably agreed upon supplementary payment terms.
- 4. Client will incur a \$25 charge for each returned check in addition to any and all bank fees attributed to the returned check.
- 5. Lots of Love Pet Care with Wendy shall exercise all precautions against sickness, injury, escape, loss, accidents or death of Client's pet(s). Lots of Love Pet Care with Wendy is not responsible for sickness, injury, escape, loss accidents or death of Client's pet(s) unless caused through negligence or willful misconduct on the part of Lots of Love Pet Care with Wendy.
 6. Lots of Love Pet Care with Wendy will follow the directions of the Veterinary Release Form in the case a pet should become injured or sick.
- 7. Client accepts responsibility for all medical expenses and other damages resulting from an injury to the Pet Sitter, other persons or other animal(s) caused by the Client's pet(s) or negligent act.
- 8. Client agrees to indemnify, hold harmless and defend Lots of Love Pet Care with Wendy in the event of a claim by any person injured or otherwise damaged by Client's pet(s) or negligent act.
- 9. Lots of Love Pet Care with Wendy reserves the right to charge a cancellation fee of 100% of the scheduled visits for services cancelled with less than 24 hours' notice prior to the scheduled service.
- 10. Lots of Love Pet Care with Wendy reserves the right to terminate this contract at any time if the Pet Sitter, in his/her sole discretion, determines that the Client's pet(s) poses a danger to the health or safety of itself, other pets, other people or the Pet Sitter. If concerns prohibit the Pet Sitter from caring for the pet, Lots of Love Pet Care with Wendy will attempt to contact to the Client to arrange alternative care. If the Client cannot be contacted, the Client authorizes Lots of Love Pet Care with Wendy to place the pet in a licensed kennel with all charges and fees arising to be the responsibility of the Client.
- 11. Lots of Love Pet Care with Wendy reserves the right to refuse service to any client, at any time, for any reason.
- 12. This document gives Lots of Love Pet Care with Wendy and its representatives authorization to enter the Client's listed address as needed to perform agreed upon services.
- 13. Client expressly gives Lots of Love Pet Care with Wendy the authority to employ a locksmith on their behalf and to promptly reimburse Lots of Love Pet Care with Wendy for all costs incurred in the event of a malfunction of the lock, keys or automatic door opener.
- 14. Lots of Love Pet Care with Wendy is not liable for any loss or damage in the event of a burglary or other crime that should occur while under this contract.
- 15. Client agrees to properly secure the home prior to leaving the premises. Lots of Love Pet Care with Wendy will re-secure the home to the best of its ability at the end of each visit.

Client is responsible for supplying the necessary equipment and supplies needed for the care of their pet(s) including, but not limited to, a sturdy, well-fit harness or collar and leash for walks or in case of emergencies, pet food, medications, identification tags, litter boxes, cat litter and cleaning supplies. Client authorizes any purchase of necessary for the satisfactory performance of duties. Costs of all purchases and related service fees will be reimbursed to Lots of Love Pet Care with Wendy with 14 days.
- 19. Client authorizes the use of pet(s) pictures on website, social media and/or marketing materials for promotional purposes.
- 20. Client authorizes this contract to be valid approval for services so as to permit Lots of Love Pet Care with Wendy to accept all future in person, telephone, online, mail or email reservations and provide services without additional signed contracts or written authorizations.
